Loudspeaker permits used in Motor Vehicles or on foot must conform to City Ordinances.

Noise of such character, intensity and duration as to be detrimental to the life or health of any individual or contrary to the public welfare is prohibited. Loud and unreasonable noise is defined by City Ordinance as "sound" which is greater than 50 decibels in the hours between 11:00 PM and 7:00 AM and 70 decibels at other times, OR ANY SOUND WHICH IS DISCERNABLE AT A DISTANCE OF 100 FEET.

I will not allow amplified devices to be used before 8:00 AM or after 4:00 PM, as it is my right under Section 38-73 sub-section (8) of the City Ordinance. I expect the bearer of such permits to use them with the aforementioned City Ordinance in mind.

All permits shall be site specific with no roaming permitted. All permits shall be used between 8:00 AM and 4:00 PM only. All permits will be granted with the stipulation that sound may not travel outside a 200 foot radius from the source of the amplification.

Noise near schools or other institutions, in violation of City Ordinance 38-73 sub-section 5 is prohibited while that institution is in session... Churches, Hospitals or Schools.

I have provided a copy of the City Ordinance so that you may be completely aware of the rules governing the conduct I expect to be followed, while operating amplified loudspeaker device.

IF USED FROM A MOTOR VEHICLE, THE VEHICLE MUST CONTAIN TWO PERSONS, ONE TO OPERATE THE VEHICLE AND THE OTHER TO OPERATE THE SOUND SYSTEM.

AUTHORIZATION IS SUBJECT TO REVOCATION IF THE INSTRUCTIONS OF ANY POLICE OFFICER CONCERNING THE USE OF THE SOUND SYSTEM ARE IGNORED.

VIOLATIONS WILL RESULT IN REVOCATION OF THIS PERMIT.
